Fall 2023 Visible Emissions (VE) Certification

A VE certification course (EPA Reference Method 9) consisting of a lecture session and several field sessions will be held October 3-5, 2023, in Bismarck at the Environmental Training Center (2639 East Main Avenue). There is no fee for the training.

The lecture session, which is mandatory for initial certification, will be limited to **30 attendees**. Registrations will be accepted by emailing <u>airquality@nd.gov</u> until September 29, 2023. Registration is accepted on a first-come, first-served basis, so early pre-registration is encouraged.

<u>Note</u>: Pre-registration is no longer required for those only needing 6-month recertifications.

A certification of attendance or completion for the on-line course will be required to satisfy the lecture component which is necessary for initial certification.

In lieu of certification cards, a list of individuals certified for 6 months will be maintained on the Training page of the Division's website: https://deq.nd.gov/AQ/Training.aspx. This list serves as the official record of certification. Certificates for initial VE Certification will be emailed to participants.

<u>A reminder for all</u>: Bring a ball point pen for use during lecture and field sessions. A type of clip board for use during field sessions will be furnished by the Department.
