Who We




The North Dakota Department of Environmental Quality has primacy for major environmental programs in North Dakota.

What is primacy?

Primacy means Environmental Quality has primary responsibility for ensuring implementation of many federal environmental regulations in the state. This agency has primacy on all North Dakota lands except tribal and reservation lands, where the U.S. Environmental Protection Agency (EPA) has jurisdiction for enforcing federal environmental law.

Our Work Matters

Environmental Quality is responsible for safeguarding North Dakota's air, land and water resources. This state agency has 170 employees who work closely with local, state and federal entities to address public and environmental health concerns and implement protection policies and programs. It consists of the Office of the Director and six divisions: Accounting, Air Quality, Chemistry, Municipal Facilities, Waste Management and Water Quality.



Environmental Quality staff inspect thousands of facilities each year to ensure that environmental laws are being followed.

Legislative Changes 67th Assembly

Legislative Changes 67th Assembly



CCR Program and Wind Blade Recycling HB 1090 clarified the definition of groundwater for the Coal Combustion Residual program that regulates coal ash waste from power plants. HB 1024 also made it illegal to dispose of wind turbine blades in landfills without Environmental Quality approval.

AFO Model Zoning **IB 1423** established a model zoning review task force for animal feeding operations. Environmental Quality will be a member of this task force.



Improved Transparency in Groundwater Data & Streamlined SRF Approvals

SB 2074 was part of Environmental Quality's red tape reduction strategy. It removed roadblocks that prevented citizens from accessing groundwater data, thereby improving transparency while maintaining appropriate privacy protections.

This bill also streamlined SRF approval by eliminating the extra step requiring the State Water Commission to approve the Intended Use Plan.



Expansion of Environmental Restoration Fund


HB 1024 expanded the the Environmental Quality Restoration Fund to include non-emergency



Environmental Justice and QA/QC Added

added an Environmental Justice/ Nondiscrimination Coordinator, and it allowed for a Quality Assurance/Quality Control Coordinator. The Environmental Justice program will ensure federal compliance with Civil Rights and Environmental Justice. It is essential all citizens understand our actions and can participate in our processes. Accurate environmental data is essential for environmental assessments and determining regulatory compliance. The QA/QC Program helps ensure proper and accurate data collection.





SB 2075 modified state law, allowing the Petroleum Tank Release Compensation Fund more flexibility when considering claim reimbursement for petroleum releases at registered sites.



Background Checks for Radioactive Permits and Licenses SB 2076 changed state law to allow Environmental Quality to run criminal background checks as part of an environmental compliance background through the FBI database for certain employees or applicants pursuing a radioactive materials license or a solid waste permit.

Clarified Abandoned Autos, Disposal and Reimbursements

clarified what is considered an abandoned auto and defined permitted scrap iron processors, scrap tires, and submerged vehicles. It also specified when an abandoned motor vehicle would be disposed of immediately and that they are not eligible for storage cost reimbursement. It amended state law to allow government units to request reimbursement for collecting and disposing of scrap tires. It also allowed Environmental Quality to reimburse commercial towing services if the owner of the abandoned motor vehicle is not identifiable.

New State Laboratory

HB 1165 dedicated funds to replace the existing lab, including the Environmental Quality Chemistry Lab, which is nearly 50 years old and faces ongoing infrastructure challenges.


